

ORDER

As per orders of the IG/BR/ASR issued vide No. 34379-480/BR-1 dt. 08.11.2018, the Director General of Police, Punjab, Chandigarh vide his office memo No. 14428-527/E-1 (1) dt. 06.11.2018 has issued the final seniority lists of Inspectors (District Cadre) after 20.02.2008 from 28.01.2015 upto 28.04.2016 after checking the eligibility.
